CTIB Votes to Dissolve

The Counties Transit Improvement Board (CTIB) voted to dissolve at its Wednesday Board meeting. With all member counties passing the necessary resolutions to dissolve, the CTIB could then finalize its dissolution. Debt and payment obligations will be addressed through the dissolution agreement.

Sales taxes collected under the CTIB will end on September 30, and with the dissolution, the five former CTIB counties may increase their sales tax to ½ cent for transportation needs including transit, roads and bridges. Anoka, Dakota and Washington counties have voted to maintain their current ¼ cent sales tax, while Hennepin and Ramsey counties have voted to increase their taxes by ½ cent.

Small Cities Account Fund Distribution by City

The new transportation bill that is now law appropriated \$16 million in one-time funds for the Small Cities Assistance Account for the 2017/18 biennium (\$8 million per year), and MNDOT has now released aid amounts for eligible cities. The Small Cities Assistance Account was created in 2015 to assist cities under 5,000 that do not qualify for Municipal Street Aid (MSA) funding, and was funded initially with a one-time appropriation of \$12.5 million. Inflow-Infiltration Grant Program and Informational Meeting

This session, Metro Cities helped to secure \$3.7 million in funding for inflow-infiltration mitigation grants through the omnibus capital investment bill, now law. A city's eligibility to access this funding is determined by whether the community is an 'excess' contributor of inflow-infiltration into the regional wastewater system, or being on the threshold of being so. Click here for a list of eligible cities. These monies can be used for eligible I/I mitigation work on local public infrastructure.

Funds will be distributed through a program administered by Metropolitan Council Environment Services (MCES). The grant program will follow state requirements and set guidelines developed for past appropriations.

Sunday Liquor Sales Law Goes into Effect July 1

A new law enacted this year allowing Sunday liquor sales will go into effect July 1st. Cities with ordinances that are consistent with laws on days and hours of operation will not necessarily need to address changes to their ordinances. If a local ordinance currently bans Sunday sales,

however, such ordinances will not be valid after July 1. The new law specifies that Sunday sales will be allowed from 11:00 am to 6:00 p.m. If a city wishes to set more restrictive Sunday hours, it may do so by ordinance. Additionally, the new law disallows the delivery of alcohol to off-sale licensees on Sundays, as well as Sunday orders by wholesalers. The language of the new law can be accessed here.

State Revenues Dip Again in May

Net state general fund revenues for May are \$63 million (4.1%) less than forecast, with individual income tax receipts coming in at \$117 million less than expected, offsetting larger receipts for other tax types. While receipts for some taxes are floating up and down, income tax receipts are at this point consistently trending downward from the most recent budget forecast, with a similar dip reported in April. The State Office of Management and Budget (MMB) notes that month-to-month receipts can vary, and should be interpreted with caution. The next complete budget forecast will be released in November 2017.

This appointment will fill the remainder of the term for this seat – until January 2019.

District 4 - includes Benton Twp., Camden Twp., Carver, Chaska, Cologne, Dahlgren Twp., Hamburg, Hancock Twp., Hollywood Twp., Laketown Twp., Mayer, New Germany, Norwood Young America, San Francisco Twp., Victoria, Waconia, Waconia Twp., Watertown, Watertown Twp., Woodland, and Young America Twp. This appointment will fill the remainder of the term for this seat – until January 2019.
